OFFER OF APPOINTMENT FOR THE POST OF CONSTABLE(GD) IN BORDER SECURITY FORCE (BSF) THROUGH STAFF SELECTION COMMISSION (SSC) EXAM-2021

1. Please refer your application for the post of Constable(GD) through SSC Exam-2021 and final result published by SSC on 07.11.2022 on their official website.

2. I am directed to inform you that, you have been **PROVISIONALLY** selected for appointment to the post of Constable(GD) in BSF in Pay Matrix Level-3 (pay scale Rs.21,700/- – 69,100/-) with initial Basic Pay of Rs.21,700/- per month plus other allowances admissible under rules from time to time. On behalf of the DG BSF & all ranks of Border Security Force, you are welcome to join the 'Elite Force', which has earned an enviable position for itself in the galaxy of "**Border Guarding Forces**" of the world, be it in peace or in war.


3. Your appointment to the above post is subject to the following terms and conditions:-

The recruitment medical examination is valid for one year from the date of fitness to join the service and if candidate join the service after validity period of recruitment medical, candidate will be examined by the medical officer for any disease/deformity that might have arisen after the recruitment medical. Hence, if your recruitment medical has completed one year then you will be examined by the medical officer to detect/discover/disability/accidental injury acquired during the intervening period of recruitment (initial) medical examination and the date of joining. (a) Your appointment is purely **provisional** till receipt of a 'no adverse' character and antecedents verification report from the concerned civil authorities. (b) You will be governed by the provisions of BSF Act-1968 and BSF Rules-1969 as amended from time to time and other Central Government Orders, Rules and Regulations, as applicable from time to time.

(c) You are entitled to get pensionary benefits as per new restructured "**DEFINED CONTRIBUTORY PENSION SYSTEM**" applicable for the new entrants to the Central Government service from **Jan 2004**. Therefore, you would make monthly contribution @10% on the basic pay and DA towards the new pension system from the date of appointment.

(d) Initially you will be on probation for a period of two years, which may be extended by the appointing authority for such further period or periods not exceeding one year, for reasons to be recorded in writing. During the period of probation, if the appointing authority considers that you are not likely to become an efficient member of the Force due to any reason, your services can be terminated without assigning any reasons or without any advance notice.

(e) The appointment carries liability to serve in any part of India and abroad.

(f) The post is temporary but likely to be made permanent in due course. In case the temporary post is abolished, your services shall be terminated without assigning any reason.
